- Commissioner Keelcy Perez connecting with DOL to bring REAL ID resources and information to events throughout the state with the assistance of Commissioners

Legislative & Decision Package Request Timelines and Process

- 2021 Legislative session will be the start of a new biennium and a new budget

- CHA shares recommendations with Governor as to what he should include in his budget
- By June: start concept paper gives 6 weeks to build in talking with stakeholders
 - Due by August to OFM
- Budgeting agency falls primarily on staff but they can tap into Commissioners asking for letters of support

Keeping on Retiring Commissioners

- Statute: 2 terms, 3 years each
- Discussion how do we create a system that we can keep commissioners integrated even if they are terming out?
 - Perhaps keeping them on as a committee member so we can continue to work together
- Proposal: Executive Committee to create a type of retention program that still has them carry on commission title
- April 10th: present proposal
