REDISTRICTING

Angie Hinojos from Centro Cultural talked about the importance of the results of the Census and the impact it has on the Latinx/Hispanic Community during redistricting. Centro Cultural Mexicano wants to work with CHA to spread awareness of upcoming changes and how they can support the community representation at this time during the process.

The Commission on Hispanic Affairs is working on a report based on the Census 2020 findings specific to Washington state Hispanics/Latinx, covering various demographics. The Commission on Hispanic Affairs will schedule a time with commissioners to meet again with Centro Cultural to discuss Census 2020 and Redistricting.
