Possible Interim Discussion

Executive Director Siguenza brought forward a striker for SB 5929 to discuss a path forward on how to adequately message the work and role of the Commission. Commissioners discussed how to ensure that we accurately portray our role within the upcoming strategic plan process.

CHA LOGO

Chair Baca suggested that we look to change the CHA logo to better reflect our current constituency in the state. Executive Director Siguenza indicated that her administration inherited the logo, and the history as to how it came about is unknown.

Commissioner Nunez supported an update to our logo and spoke of the reality of people coming from other places and the importance of making them feel like Washington is there home too by adding the Pacific Northwest to our identity.

Chair Baca suggested to have a committee formed to start the conversation to create a new logo. The ideal would be to ask for collaboration and allocate funding to pay an artist. Vice Chair Moreno suggested for commissioners to push their \$150 commission recognition funds for the project. Commissioners agreed and the following members will make up the Logo Committee:

STRATEGIC PLANNING

Vice Chair Moreno lead the discussion of strategic planning for CHA. Using the example from the Washington State Leadership Board, he presented the following sample format for planning:

- Quarterly meetings should be full day meetings to really talk about the relationships, the work being done, and where support is needed.
- Individual action plans by establishing 3-5 objectives of "what I want to accomplish in my time at the commission."

Vice Chair Moreno explained that it would be helpful to understand each other's strengths and weaknesses to better help each other.

Executive Director Siguenza suggested a timeline of 6 months to have it done by September to be the guiding point for our decision packages. Commissioners discussed meeting dates and agreed to meet on the following date and location:

MEXICAN CONSULATE
